I'd like to start my message by thanking Marty McPherson and his family for hosting the 2013 TOTFA convention November 9 & 10 at the Glen Rose Expo Center, in conjunction with the Dale McPherson Memorial Fiddle contest. We also enjoyed food and a jam at the McPherson home Saturday night following the contest. I think everyone in attendance would agree, the expo center was a great facility for this event, and the McPherson's are gracious hosts.

Business discussed in the meeting included changes in some bylaws, most notable, in membership status. The bylaw was voted on and passed, giving all members (fiddler, out-of-state fiddler, accompanist & associate) equal status in voting and holding office. Additionally, fiddler and accompanist members are combined to be, "a musician member," with all musician members being eligible for judging.

Concerning equality among members, it was felt that due to low membership and low participation among current members, that any member willing to devote their time and effort for the advancement of the TOTFA should be able to do so.

The board of directors is aware that his will not sit well with some, but bluntly put, if you don't approve, we urge that you renew your membership, attend contests and conventions, and become an active part of the voting process. That may appear a pretty brash statement to some people, but the

A new board of directors was voted on, and the outcome was:

- 7. Other items
  - Dress code for contestants: Many older audience members \* pay attention to dress. Board encourages proper dress and timely appearance when a contestant is called to stage.
  - \* Improvements to contests: hire judges prior to the contest, recruit good MC and contest helpers, create a contest packet to help contest run more smoothly.
- 8. Marty McPherson has expressed interest in hosting the 2014 TOTFA contest and convention. John motioned we combine the TOTFA convention/contest with the Dale McPherson Memorial contest in Glen Rose, Texas in 2014. Bart seconded, motion carried.
- 9. Membership is important. Consolidate member list, review expirations, and remind members to renew.
- 10. Discussed fund raiser before March 2014 if possible.
- 11. Next board meeting scheduled for December 21, 2013.
